Information for Authors

The publication of Kingston University Research & Innovation Reports (KURIR) is currently underwritten by Kingston University - Faculty of Computing, Information Systems & Mathematics and Kingston University - Learning Resources Centre.

Authors associated in any way with Kingston University and the West Focus HEIs are invited to submit manuscripts for publication. Please submit in the first instance by e-mail to the acting Editor-in-Chief, Dr. Robert B. Mellor; r.b.mellor@kingston.ac.uk. The language of the journal is English.

By the act of submission to KURIR, authors guarantee that the article has not been submitted or published elsewhere. Authors are guaranteed that articles published in KURIR will be permanently available to the academic community. However please note that the copyright on articles published in KURIR remains with the author(s) and is not transferred to KURIR. Thus, under exceptional circumstances, publications may be removed, but markers will remain indicating their previous existence.

Types of publication fall into three classes; peer-reviewed scientific publications, theses/dissertations (which are considered as having been reviewed by the examiners) and White Papers. Theses will be published according to the following permissions criteria:

Authors are advised to submit for the first category - scientific publications - to KURIR which are likely to be of broad international interest, although articles of interest to the local and business community will not be rejected on those grounds. Only high-class articles will be published and the journal reserves the right to reject submitted manuscripts outright which, in the opinion of the Editorial board, do not reach this standard. Prospective scientific publications will be peer-reviewed by two referees and potential contributors are encouraged to suggest names of potential referees (please enclose their e-mail addresses).

Once an article has been reviewed and, subject to any necessary minor revision, deemed acceptable for publication by referees and members of the journal editorial board, authors will be asked to suggest metadata with a short abstract and key words. The Kingston Library will then organise this to correspond to Dublin Core and the Library of Congress Subject Headings, whereupon it will be published, with an ISSN Number, on the Internet site (<http://kurir.kingston.ac.uk>) and where interested parties

may access it free of charge. Authors will be made aware of the exact URL their article possesses.

Articles are published chronologically, one volume per year, rather than being bundled together in 'disciplines'. Articles can therefore be published with exceptional rapidity (i.e. within a matter of weeks of initial submission). No hard copies of the article are made. Volumes will have continuous pagination and an annual index.

KURIR & Kingston University will make every effort to ensure a 24 hour continuity of service. However the guarantee of service does not cover temporary unavailability due to hardware or software faults or due to changes in the terms of access to the World Wide Web / Internet beyond the control of Kingston University.

It is proposed that articles will remain available on the Web for a number of years (10). If it becomes necessary or more effective to store and disseminate articles by some other method, then the permission of authors who have published in KURIR under these terms and conditions will be sought before removing the article from the Internet.

Please include in your e-mail submission a complete list of files and filenames so we can check that the entire manuscript transferred correctly. Submissions should be in Word or, if using e.g. Latex, in PDF format. Upon publication files will be converted to PDF format. Submissions in formats other than Word or PDF should include the names and versions of the applications used in creating the files, together with the format the files are saved in.

Authors who wish to embed interactive or animation technology (such as Chemscape's Chime plug-in or Java applets) into their papers should contact us to discuss the possibilities.

Formats

All electronic copies of text files should be saved in Word (.doc) or Portable Document (PDF) format, to ensure all formatting is properly transferred. Graphics should be stored as TIFF, PICT, GIF or JPEG files and sent separately as well as being included in the Word document, with as close to final formatting as possible. Spreadsheets should be saved as text files.

The main body of text (hard copy or electronic versions) should be presented as single spaced text in one column. The text format should follow the following sequence: Title, Author & Affiliation, Abstract, Abbreviations and Definitions (where appropriate), Introduction, Materials & Methods, Results, Discussion (or unified as Results & Discussion, where appropriate), Literature.

Layout style is as follows and must be strictly adhered to:

Font: Times New Roman

Size: Title: 16 pt., body text: 12 pt.

Headings should be presented in bold type, size 14 pt.

Examples of blocks of code in the text can be presented in Courier font, size 10 pt.

Latin words or other non-English expressions should be presented in italics.

Authors should follow established international nomenclature when formatting fossil and other taxonomic names, etc.

Figure and table captions should be given in the following style:

Fig. 1: Followed by text referring to figure caption, in italics

Table 1: Followed by text referring to the table, in italics

References should be formatted in the style given below:

Citation in text:

Single author; author (year) or (author year). Two authors should be separated by an ‘&’ (ampersand symbol), e.g. (Smith & Jones 1997). Three or more authors; second and subsequent authors replaced by: *et al.* e.g. (Smith *et al.* 1997)

References in the literature section:

All information such as journal titles etc to be given in full. No abbreviations. The first line of the reference should be flush with the left hand margin. All names should be expressed with the surname followed by the initial, e.g. Smith, T.H.

For each type of reference the general format is given with an example on the line below:

Journal Paper

Authors. (Year). Title. Journal, vol. no, pages. - e.g. Denning, P. (1982). Electronic Junk. Communications of the ACM, 3, 163-165.

Conference Proceedings / Edited Book

(a) if published in academic periodical.

Author. (Year). Title. in Journal Special Volume no., page-page - e.g. Smith, T.H. (1997). Mineral Exploration in the Andes. in Electronic Geology Special Volume 1: 10-26. If several authors, use &, e.g. Cranor, L. F. & LaMacchia, B. A. (1998). Spam! Communications of the ACM, 41, 74-83.

(b) if published elsewhere.

Authors. (Year). Title. in Book Title. [Edited by: editor(s)]. Publishers, location. page-page. - e.g. Mellor, R. B., (2002). DHTML, Learning by Example. Franklin Beedle, Wilsonville. 15-22.

Book / Report / Memoir

Authors. (Year). Title. Publishers. no of pages – e.g. Mellor, R. B. (2003). The Web Managers Handbook. Globe, Copenhagen. 295 pages.

Internet resources

Author, or responsible organization if no author is specified. (Year). URL – e.g. BBC (2003). Spam Attack.
